



35th IAFA Annual Conference and Doctoral Colloquium University of Galway 7-9th June, 2023

The 35th IAFA Annual Conference and Doctoral Colloquium was hosted by University of Galway on 7-9th June 2023. With over 35 doctoral students, 130 delegates and 58 conference papers, this was the largest ever IAFA Doctoral Colloquium and Conference and it showcased the very best of accounting and finance research.

The conference was organised by Dr John Nolan and was opened by Professor Geraint Howells, Executive Dean, College of Business, Public Policy and Law, University of Galway. The main conference was preceded by the Doctoral Colloquium on 7th June 2023, chaired by Professor Joan Ballantine, University of Ulster. This event provided an opportunity for both current and prospective doctoral students to learn more about the research process, research methodologies and publishing academic work. 29 current doctoral students presented their work and received feedback from experienced academics.

During the main conference, 58 research papers were presented across a broad range of topics from corporate governance, accounting education, financial literacy, sustainability reporting, taxation, performance measurement, management control, and much more.

The conference keynote address was given by Professor Lukas Goretzki, Professor of Management Accounting & Control, Stockholm School of Economics on the topic of "Exploring the intricacies of management accountants' identity work"

The *Meet the Editors* session was another highlight of the conference this year. A panel of editors introduced their publications, gave advice on how to write papers for successful publication, and highlighted common pitfalls to avoid.

Professor Lukas Goretzki, Professor of Management Accounting & Control, Stockholm School of Economics

Editor of Qualitative Research in Accounting & Management (QRAM)

Professor Martin Quinn from Queen's University Belfast was also on hand to launch a special issue for the Accounting, Finance, and Governance Review on "Systematic literature reviews in Accounting, Finance and Governance".
